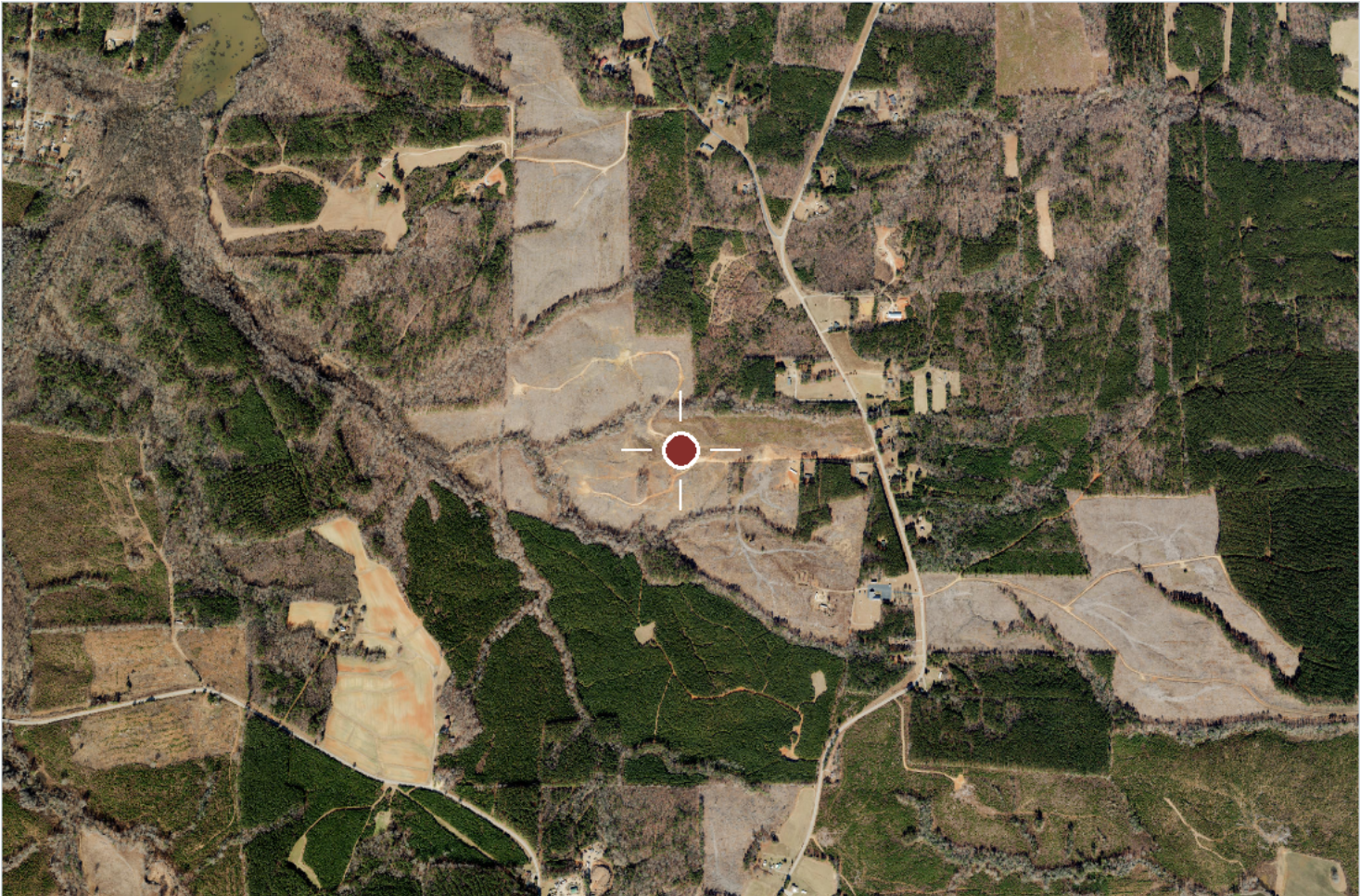

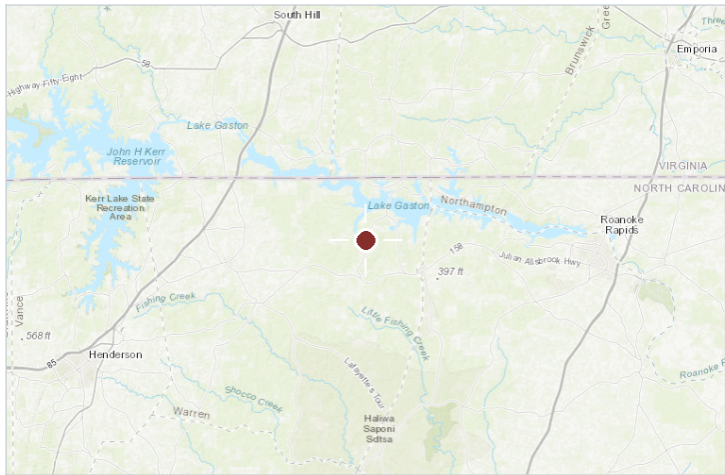

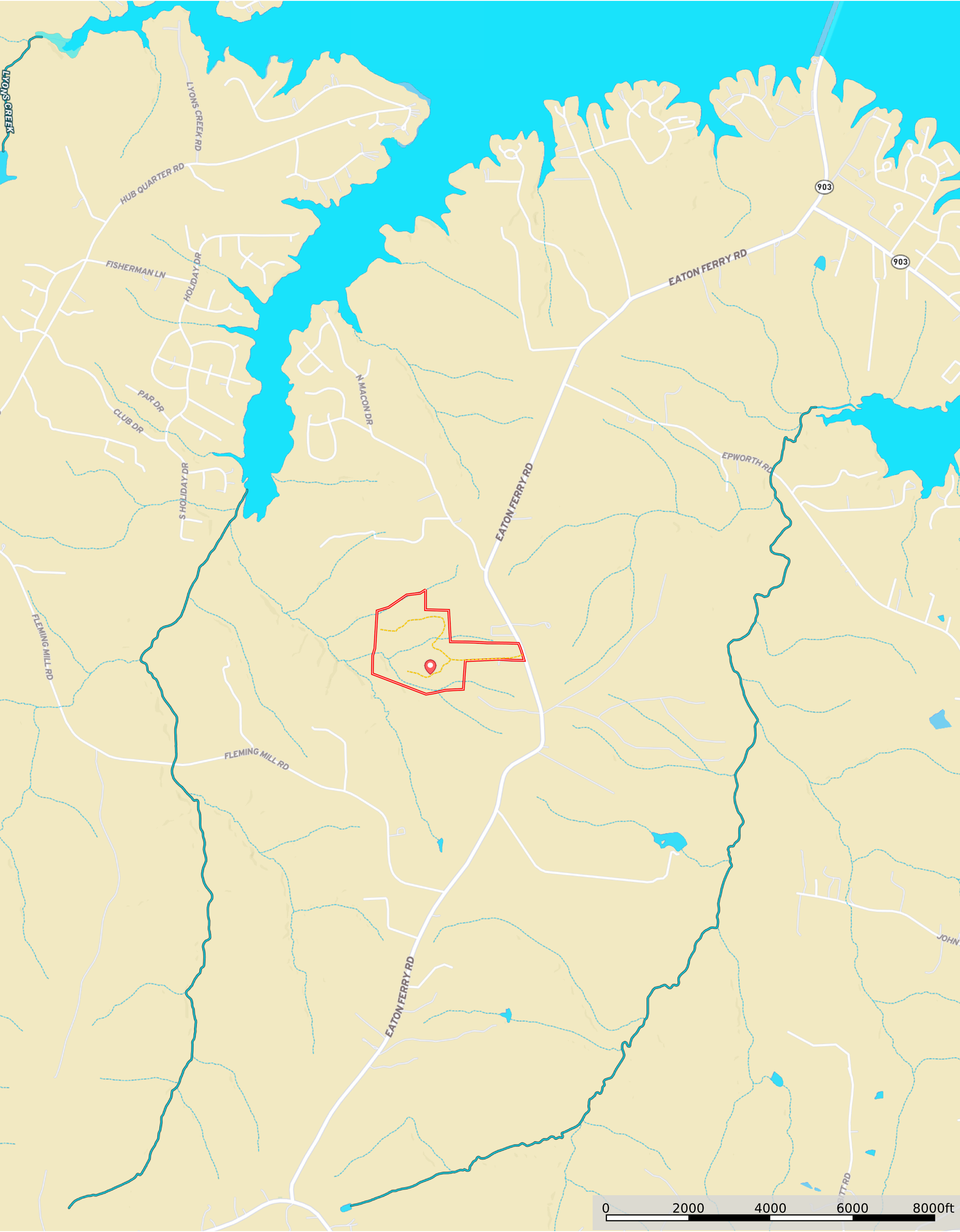

THAT, for and in consideration of the sum of One Dollar, other good and valuable consideration, the parties of the first part have conveyed and by these presents do convey unto the party of the second part, the following described land in River Township, Warren County, North Carolina:

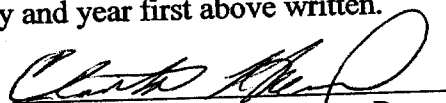
BEGINNING at a corner common to this property and the property of N. E. Booker, on the western edge of the right of way of State Road No. 1344, marked by an iron; thence North 10. 53' West 278.5 feet along the western edge of the right of way of said road to a point; thence continuing along the western edge of the right of way of said road North 16. 15' West 171.3 feet to a corner common to this property and property of Willie L. Carter; thence along the property line dividing this property and property of said Willie L. 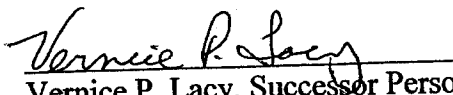

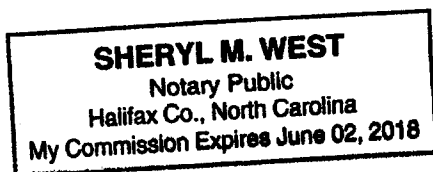

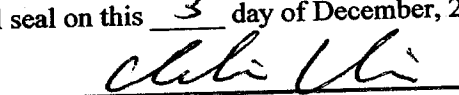
